Whereas, The Common Council of the City of Milwaukee has previously approved the 2014 CDBG award of \$100,000 to Running Rebels, Inc. for the "Be The Change" Program; and

Whereas, Running Rebels, Inc. has notified the Community Development Grants Administration (CDGA) in the attached letter of their intent to transfer program responsibilities and to transfer the remainder balance of funding in the amount of \$87,339 to Universal Community Homes.; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Community Development Grants Administration is authorized to transfer the 2014 CDBG remaining balance of \$87,339 to Universal Community Homes.; and, be it

Further Resolved, That Universal Community Homes. shall submit budget and activity reports in amounts and according to any conditions approved by the Common Council and in accordance with File Number 74-92-5v, to the Community Development Grants Administration and the City Comptroller for review and approval; and, be it

Further Resolved, That payments for CDBG cost incurred shall be paid in accordance with approved
