### 141514 Substitute 1 THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$2,165,000 for a total estimated cost of these projects being \$20,455,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$2,165,000 with the total cost estimated to be \$20,455,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

#### 2nd Aldermanic District

W. Custer Ave. - N. 87th St. to N. 91st St. (WT410160624): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$295,000. This project is anticipated to be completed during the 2016 construction season.

N. 80th St. - W. Thurston Ave. to W. Carmen Ave. (WT410160620): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$170,000.

This project is anticipated to be completed during the 2016 construction season.

N. 84th St. - W. Carmen Ave. to W. Bobolink Ave. - (WT410160621): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$160,000. This project is anticipated to be completed during the 2016 construction season.

#### 4th Aldermanic District

Michigan Street Bridge (100W) over the Milwaukee River (BR100150104): Preliminary in-house and consultant engineering for movable bridge rehabilitation including structural, mechanical, and electrical. (City Share Non-assessable Structure Fund -- \$1,200,000). The total estimated cost for this project including the requested amount is \$10,700,000. This project is anticipated to be completed during the 2017 construction season.

E. Michigan St. - N. Cass St. to 210 feet east of N. Cass St. (WT410150696): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2015 construction season.

W. Richardson Pl. - N. 28th St. to N. 29th St. (WT410160617): Relaying water main. (Nonassessable Sewer Maintenance Relay Fund -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2016 construction season.

N. 33rd St. - W. Wells St. to 250 feet m/l north of W. Wells St. (SM495150003): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2015 construction season.

#### 5th Aldermanic District

W. Concordia Ave. - N. 88th St. to N. 89th St. (WT410160600): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2016 construction season.

W. Hadley St. - N. 88th St. to N. 89th St. (WT410160610): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2016 construction season.

W. Hadley St. - N. 91st St. to N. 92nd St. (WT410160611): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2016 construction season.

N. 86th St. - W. Hadley St. to W. Locust St. (WT410160613): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000).

The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2016 construction season.

N. 88th St. - W. Center St. to W. Hadley St. (WT410160612): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2016 construction season.

N. 90th St. - W. Auer Ave. to W. Concordia Ave. (WT410160602): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2016 construction season.

N. 92nd St. - W. Auer Ave. to W. Concordia Ave. (WT410160601): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2016 construction season.

#### 5th and 10th Aldermanic Districts

Area bounded by W. Center St., W. Vienna Ave., N. 59th St., and N. Argonne Dr. (SM494150202): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$30,000). The total estimated cost for this project including the requested amount is \$2,866,000. This project is anticipated to be completed during the 2015 construction season.

#### 6th Aldermanic District

W. Atkinson Ave. - N. 12th St. to N. 13th St. (WT410160609): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2016 construction season.

N. Holton St. - E. Meinecke Ave. to E. Wright St. (SM495150005): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$129,000. This project is anticipated to be completed during the 2015 construction season.

#### 7th Aldermanic District

W. Capitol Dr. (Southside) - N. 29th St. to N. 30th St. (WT410160607): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2016 construction season.

W. Maxwell Pl. - N. 52nd St. to W. Fond du Lac Ave. (WT410160605): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2016 construction season.

W. Melvina Pl. - N. 30th St. to N. Hopkins St. (WT410160606): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$45,000. This project is anticipated to be completed during the 2016 construction season.

N. 30th St. - W. Melvina Pl. to W. Capitol Dr. (WT410160608): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2016 construction season.

N. 38th St. - W. Glendale Ave. to W. Courtland Ave. (WT410160619): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2016 construction season.

N. 42nd St. - W. Glendale Ave. to W. Peck Pl. (WT410160618): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2016 construction season.

W. Vliet St. - N. 45th St. to N. 49th St. (SM495150004): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$283,000. This project is anticipated to be completed during the 2015 construction season.

#### 11th Aldermanic District

Area bounded by W. Cleveland Ave., W. Arthur Ave., S. 67th St, and S. 71st St. (SM494150201): Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$309,000. This project is anticipated to be completed during the 2015 construction season.

W. Dodge Pl. - 70 feet southeast of W. Wilbur Ave. to 570 feet southeast of W. Wilbur Ave. (WT410160623): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2016 construction season.

W. Kinnickinnic River Pkwy. - S. 29th St. to 340 feet m/l east of S. 29th St. (SM495150007): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2015 construction season.

W. Ohio Ave. - S. 76th St. to S. 80th St. (WT410160627): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$315,000. This project is anticipated to be completed during the 2016 construction season.

W. River Bend Dr. - W. Ohio Ave. to W. Verona Ct. (WT410160603): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2016 construction season.

W. Verona Ct. - S. 77th St. to S. 79th St. (WT410160626): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2016 construction season.

W. Warnimont Ct. - S. 68th St. to 160 feet west of S. 68th St. (WT410160622): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2016 construction season.

S. 77th St. - 500 feet north of W. Burdick Ave. to W. Morgan Ave. (WT410160625): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$17,000; Nonassessable Water Fund Budget Line 6410 -- \$18,000). The total estimated cost for this project including the requested amount is \$550,000. This project is anticipated to be completed during the 2016 construction season.

The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2016 construction season.

S. Pine St. - E. Layton Ave. to 150 feet m/l north of E. Layton Ave. (SM495150002): Storm relocation. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$71,000. This project is anticipated to be completed during the 2015 construction season.

W. Whitaker Ave. - S. 20th St. to S. Louisiana Ave. (WT410160604): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$175,000. This project is anticipated to be completed during the 2016 construction season.

S. 25th St. - W. Holt Ave. to W. Morgan Ave. (WT410160614): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2016 construction season.

S. 26th St. - W. Ohio Ave. to W. Holt Ave. (WT410160615): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2016 construction season.

S. Austin St. - E. Warnimont Ave. to E. Morgan Ave. (SM495150006): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$139,000. This project is anticipated to be completed during the 2015 construction season.

S. 4th St. - W. Becher St. to S. Chase Ave. (SM495130070): Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000, Additional Funds). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2015 construction season.

The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2015 construction season.

Work done by Contractor-Sewer Alterations (WT410150770): Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$5,000). construction season.

Material inspection at various locations (WT410150880): Inspection. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$15,000). The total estimated cost for this project is \$15,000. This project is anticipated to be completed during the 2015 construction season.
