Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$15,148,000 for a total estimated cost of these projects being \$16,613,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$15,148,000. The total estimated cost of these projects is \$16,613,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

## 1st Aldermanic District

W. Port Sunlight Way - N. 26th St. to N. 27th St. (SM495140053) File Number 140039: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$68,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2015 construction season.

N. 27th St. - 110 feet m/l south of W. Stark St. to W. Lancaster Ave. (SM495130076) File Number 130599: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$305,000). The total estimated cost for this project including the requested amount is \$320,000. This project is anticipated to be completed during the 2015 construction season.
