Substitute 2

THE CHAIR

A substitute ordinance relating to parking controls.

This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

“On the southeasterly side of South Kinnickinnic Avenue from a point 350 feet east of the east curb line of South California Street to a point 762 feet east of the east curb line of South California Street”

“On the north side of West Everett Street from the east line of North 3<sup>rd</sup> Street to the east line of North 4<sup>th</sup> Street (except taxicabs)”

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the west side of South Kinnickinnic Avenue from to a point 265 feet south of South California Street to a point 100 feet south thereof

Part 3. Section 101-23-8 of the Code relating to Taxicab Stands is amended by striking the following:

“On the south side of West Everett Street from North 3<sup>rd</sup> Street to North 4<sup>th</sup> Street”

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

“On East Florida Street from South 1<sup>st</sup> Street east to the bridge”

“On West Florida Street from South 1<sup>st</sup> Street to South 3<sup>rd</sup> Street”

“On the east side of North 84<sup>th</sup> Street from West Burleigh Street to a point 130 feet south”

“On the south side of West National Avenue from South 8<sup>th</sup> Street to South 9<sup>th</sup> Street”

Part 5. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by adding the following:

On West Everett Street from North 3<sup>rd</sup> Street to North 4<sup>th</sup> Street from 8:00 AM to 6:00 PM on Saturday

Part 6. Section 101-23-4-e of the Code relating to Three-Hour Parking is amended by adding the following:

On the south side of West National Avenue from South 8<sup>th</sup> Street to South 9<sup>th</sup> Street from 7:00 AM to 7:00 PM Except Sunday

Part 7. Section 101-32-3-c-4 of the Code relating to One-Hour Meter Parking is amended by striking the following:

“On West Everett Street from North 3<sup>rd</sup> Street to North 4<sup>th</sup> Street”

Part 8. Section 101-32-3-d-2 of the Code relating to Two-Hour Meter Parking is amended by striking the following:

“On West National Avenue from South 6<sup>th</sup> Street to South 7<sup>th</sup> Street from 9:00 AM to 6:00 PM Except Sunday”

“On the south side of West National Avenue from South 6<sup>th</sup> Street to South 7<sup>th</sup> Street from 9:00 AM to 6:00 PM”

Part 9. Section 101-32-3-d-3 of the Code relating to Two-Hour Meter Parking is amended by adding the following:

On West Everett Street from North 3<sup>rd</sup> Street to North 4<sup>th</sup> Street from 8:00 AM to 6:00 PM Monday through Friday

Part 10. Section 101-32-3-e-1 of the Code relating to Three-Hour Meter Parking is amended by adding the following:

On West National Avenue from South 6<sup>th</sup> Street to South 7<sup>th</sup> Street from 9:00 AM to 6:00 PM Except Sunday
