Whereas, The Capital Improvements New Streets Developer Account, No. 0333-5010-R999-ST21415000A, was funded in the amount of \$400,000 in the 2015 adopted budget; and

Whereas, This account provides funding on a temporary basis for projects which receive partial reimbursement from the municipalities with which the project is undertaken, but require the city to front the project cost; and

Whereas, The city's participation in a project to reconstruct West County Line Road from North 68<sup>th</sup> Street to North 91<sup>st</sup> Street with the City of Mequon is scheduled to go to bid in April 2015 has resulted in a need for \$1,000,000 in additional funds to be reimbursed by Mequon; now, therefore, be it
