## THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$495,000 for a total estimated cost of these projects being \$6,355,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$495,000 with the total cost estimated to be \$6,355,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

## 2nd and 7th Aldermanic Districts

W. Fond du Lac Ave. Bioswales - W. Capitol Dr. to W. Hampton Ave. (SM499150102): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$10,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2016 construction season.

## 3rd Aldermanic District

N. Newhall St. - 200 feet m/l north of E. Bradford Ave. to E. Webster Pl. (SM495150021): Relaying

combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$128,000. This project is anticipated to be completed during the 2016 construction season.

E. Webster PI. - N. Newhall St. to N. Bartlett Ave. (SM495150022): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$92,000. This project is anticipated to be completed during the 2016 construction season.

### 3rd and 4th Aldermanic Districts

N. Prospect Ave. - E. Kane PI. to E. Royall PI. (SM495150023): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$61,000. This project is anticipated to be completed during the 2016 construction season.

#### 4th Aldermanic District

N. Cass St. - E. State St. to E. Wells St. (SM495150014): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$244,000. This project is anticipated to be completed during the 2016 construction season.

W. St. Paul Ave. - N. 4th St. to N. 6th St. (SM495150015): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed during the 2016 construction season.

#### 6th Aldermanic District

W. Keefe Ave. - N. 17th St. to 40 feet m/l west of N. 24th Pl. (SM495150025): Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$3,546,000. This project is anticipated to be completed during the 2016 construction season.

W. Townsend St. - N. 20th St. to N. 22nd St. (SM495150016): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$121,000. This project is anticipated to be completed during the 2016 construction season.

#### 7th Aldermanic District

N. 53rd St. - W. Roosevelt Dr. to W. Keefe Ave. (SM495150020): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$166,000. This project is anticipated to be completed during the 2016 construction season.

N. 55th St. - W. Nash St. to W. Vienna Ave. (SM495150013): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this

project including the requested amount is \$155,000. This project is anticipated to be completed during the 2016 construction season.

## 10th Aldermanic District

N. 46th St. - W. Juneau Ave. to W. Martin Dr. (SM495150017): Storm sewer lining and sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$123,000. This project is anticipated to be completed during the 2015 construction season.

N. 48th St. - W. Vliet St. to W. Cherry St. (SM495150019): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$123,000. This project is anticipated to be completed during the 2015 construction season.

## 11th Aldermanic District

W. Burdick Ave. - S. 77th St. to S. 80th St. (WT410160629): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$10,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$225,000. This project is anticipated to be completed during the 2016 construction season.

Lynndale Neighborhood-Joint City of Greenfield Project (SM495150028): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2015 construction season.

Area bounded by W. Montana St., W. Oklahoma Ave., S. 44th St., and S. 49th St. (SM494150203): Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2015 construction season.

S. 82nd St. - W. Morgan Ave. to W. Holt Ave. (SM495150024): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$33,000. This project is anticipated to be completed during the 2016 construction season.

## 13th Aldermanic District

S. 13th St. - W. Waterford Ave. to a point north of W. Waterford Ave. (SM495150026): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$119,000. This project is anticipated to be completed during the 2016 construction season.

## 14th Aldermanic District

S. Clement Ave. - E. Montana St. to E. Pryor Ave. (SM495150018): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed

during the 2016 construction season.

15th Aldermanic District

N. 18th St. - W. Walnut St. to W. Galena St. (SM495150012): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2015 construction season.

City Wide

Pavement Management Analysis (PMA) - Administration and maintenance of pavement inventory database. (Nonassessable Reconstruction Paving Fund -- \$220,000, Additional Funds). The City Comptroller is authorized to transfer \$220,000 from the Major Street Improvement parent account 0333-ST320150000, to an expenditure account previously created within the Capitol Improvement Fund- Grant and Aid Projects (ST30581901) for the PMA. The total estimated cost for this project including the requested amount is \$220,000. This project is anticipated to be completed during the 2015 construction season.
