The City cost of the projects approved by this resolution is estimated to be \$1,930,000. The total estimated cost of these projects is \$2,259,123.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

5th Aldermanic District

W. Good Hope Rd. (Southside) - N. Park Manor Dr. to N. 98th St. (WT410140651) File Number 140280: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$18,000; Nonassessable Water Fund Budget Line 6410 -- \$342,000). The total estimated cost for this project including the requested amount is \$380,000. This project is anticipated to be completed during the

2015 construction season.

N. Park Manor Dr. - W. Green Tree Rd. to W. Debbie Ln. (WT410140652) File Number 140280: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$11,000; Nonassessable Water Fund Budget Line 6410 -- \$214,000). The total estimated cost for this project including the requested amount is \$240,000. This project is anticipated to be completed during the 2015 construction season.

W. Rochelle Ave. - N. Park Manor Dr. to N. 98th St. (WT410140650) File Number 140280: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$14,000; Nonassessable Water Fund Budget Line 6410 -- \$286,000). The total estimated cost for this project including the requested amount is \$320,000. This project is anticipated to be completed during the 2015 construction season.

(Nonassessable Water Fund Budget Line 5010 -- \$11,000; Nonassessable Water Fund Budget Line 6410 -- \$249,000). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2015 construction season.
