### Chair

Substitute resolution relative to acceptance and funding of the Implementing Voluntary National Retail Food Regulatory Program Standards Grant from the Food and Drug Administration (FDA).

This resolution authorizes the Health Department to accept and fund the 2015-16 Implementing Voluntary National Retail Food Regulatory Program Standards Grant from the Food and Drug Administration (FDA) in the amount of \$70,000. The purpose of the grant is to allow MHD to examine current policies and procedures in the Consumer Environmental Health Section and provide an opportunity to adopt best practices to improve the program.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Food and Drug Administration (FDA) for the 2015-16 Implementing Voluntary National Retail Food Regulatory Program Standards Grant in order to examine current policies and processes and procedures in the Consumer Environmental Health Section and provide an opportunity to adopt best practices to improve the program; and

Whereas, The operation of this grant project from 07/1/15 to 06/30/16 would cost \$70,000 which

would be provided entirely by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the acceptance of the grant from the Food and Drug Administration (FDA) is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2015 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled 2015-16 FDA Standards Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amount required under the grant agreement;

2. Expend from the 2015 grant budget funds for specific items of equipment;
3. Expend from the 2015 grant budget funds for training and out-of-town travel by departmental staff;
4. Enter into subcontracts as detailed in the grant budget; and, be it
