THE CHAIR

Resolution approving a final Certified Survey Map for property located at 102 East Keefe Avenue and 3613 North Palmer Street for expansion of an existing business and dedication of land for public purposes, in the 6th Aldermanic District.

This resolution approves a final Certified Survey Map that combines two parcels into one for expansion of an existing business (Medovations), creates one outlot and dedicates land for the construction of a new alley leg.
