Whereas, The YMCA-Holton has notified the Community Development Grants Administration (CDGA) of their plan to no longer provide youth services at YMCA-Holton location. The CDBG amount remaining is \$19,896.39; and

Whereas, The amount of \$19,896.00 from the YMCA-Holton 2008 CDBG funding and the activity for Youth Services is transferred to YMCA-Northside; now therefore, be it

Resolved That the Common Council of the City of Milwaukee hereby approves the transfer in the amount of \$19,896.00 of 2008 CDBG funding and activity from the YMCA-Holton to YMCA-Northside; and, be it

Further Resolved, That YMCA-Northside shall submit a budget and activity report in the amount approved above and according to any conditions approved by the Common Council and in accordance with File Number 74-92-5v, to the Community Development Grants Administration and

the City Comptroller for review and approval; and, be it

Further Resolved, That payments for CDBG costs incurred shall be paid in accordance with approved CDBG reimbursement policy based on the approval by the Community Development Grants Administration and the City Comptroller; and, be it
