This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$720,000. The total estimated cost of these projects is \$5,756,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

### 4th Aldermanic District

W. McKinley Blvd. - N. 26th St. to N. 34th St. (SM495060056) File Number 061496: Relay combined sewer and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$500,000 Additional funds). The total estimated cost for this project including the requested amount is \$5,356,000. This project is

anticipated to be completed during the 2009 construction season.

8th and 11th Aldermanic Districts

S. 43rd St. at W. Oklahoma Ave. (including crossing at W. Dakota St., W. Manitoba St., and W. Forest Home Ave. (ST320070601) (2984-77-70) File Number 061546: Island modification, Curb Push out, sidewalk and sodding, grading where necessary. (Grantor Reimbursable Paving Fund -- \$220,000).

These funds are to be transferred to the construction accounts (ST3200706XX) (2984-77-70).
