W. Perkins Pl. - W. Appleton Ave. to N. 76th St. (ST211080121) File Number 080004: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$6,400; Nonassessable Reconstruction Paving Fund -- \$85,000). The total estimated cost for this project including the requested amount is \$105,400. This project is anticipated to be completed during the 2009 construction season.

## 4th Aldermanic District

W. Wells St. - N. 13th St. to N. 16th St. (ST211080137) File Number 080240: Install median, special treatment. (Assessable Reconstruction Paving Fund -- \$100,000; Nonassessable Reconstruction Paving Fund -- \$90,000). The total estimated cost for this project including the requested amount is \$205,000. This project is anticipated to be completed during the 2008 construction season.

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects: W. Perkins Pl. (ST211080121) and W. Wells St. (ST211080137) will be billed after January 1, 2011, but not before 12 months after the project contract has been completed; and, be it
