Substitute resolution relative to acceptance and funding of the 2015-16 Preventive Health Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department accept and fund the 2015-16 Preventive Health Grant from the Wisconsin Department of Health Services in the amount of \$54,461. The purpose of the contract is to provide funding to develop a Community Health Assessment (CHA) and Community Health Improvement Plan (CHIP) which are both prerequisites for the accreditation process.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin Department of Health Services for the 2015-16 Preventive Health Grant to develop the Community Health Assessment and Community Health Improvement Plan for the accreditation process; and

Whereas, The operation of this grant project from 10/01/15 to 09/30/16 would cost \$54,461 which would be provided entirely by the grantor; now, therefore, be it
