Substitute resolution relative to acceptance and funding of the Advancing Voluntary National Retail Food Regulatory Program Standards Grant from the Food and Drug Administration (FDA).

This resolution authorizes the Health Department to accept and fund the 2015-20 Advancing Voluntary National Retail Food Regulatory Program Standards Grant from the Food and Drug Administration (FDA) in the amount of \$350,000. The purpose of the grant is to implement the nine Voluntary National Retail Food Regulatory Program Standards (VNRFRPS) which represent best practices for food inspector training and standardization, program quality assurance and monitoring, inspection content and frequency as well as industry and community relations.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Food and Drug

Administration (FDA) for the 2015-20 Advancing Voluntary National Retail Food Regulatory Program Standards Grant in order to implement these standards of best practices into the Consumer Environmental Health Section; and

Whereas, The operation of this grant project from 09/10/15 to 06/30/20 would cost \$350,000 which would be provided entirely by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the acceptance of the grant from the Food and Drug Administration (FDA) is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2015 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled 2015-20 FDA Advancing Standards Grant:

- 4. Enter into subcontracts as detailed in the grant budget; and, be it
