Whereas, Common Council Resolution #150272 authorized the Health Department to accept and fund the Public Health Emergency Preparedness Ebola 2 Grant funds from the State of Wisconsin - Department of Health Services to assure the support of accelerated state and local public health preparedness planning and operational readiness for responding to Ebola. This grant provided for a Grantor share total of \$111,180; and

Whereas, the total expenditures of this program has not change. An amended budget is requested and necessary for the grant; and

Whereas, The operation of this grant project from 04/01/15 to 09/30/16 would cost the same and is entirely provided by the grantor; now, therefore, be it
