This resolution amends Common Council File #141105 relative to the acceptance and funding of the 2015 Hepatitis B Immunization Grant project from the State of Wisconsin - Department of Health Services. This grant provided for a Grantor share total of \$15,000. The purpose of the project is to assure that pregnant women who test positive for hepatitis B are identified and that their infants and household contacts receive appropriate treatment.
