ALD. BOHL

A substitute ordinance relating to a private ambulance dispatch fee.

75-15-14-e cr

This ordinance provides for a \$10 fee to be assessed for each call assigned by the city to a private ambulance service provider. The private service provider is authorized to bill \$15 to the patient. A fee of \$10 shall be paid by the private service provider to the city.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 75-15.14-e of the code is created to read:

75-15. Ambulance Certification Regulations.

14. DETERMINING RATES BILLED BY PRIVATE SECTOR PROVIDERS.

e. In addition to the charges authorized in par. c, a private sector provider dispatch charge of \$15 shall be assessed, of which \$10 shall be paid to the city.
