Substitute resolution relative to the acceptance and funding of the Flu on Call Demonstration Grant from the National Association of County and City Health Officials (NACCHO).

This resolution authorizes the Health Department to accept and fund the Flu on Call Demonstration Grant from the National Association of County and City Health Officials (NACCHO) in the amount of \$45,000. The purpose of the grant is to establish a coordinated, national network of telephone triage lines to be used during a severe pandemic or other major public health event.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the National Association of County and City Health Officials (NACCHO) for the Flu on Call Demonstration Grant to assure that the Milwaukee Health Department is able to establish a coordinated, national network of telephone lines; and

Whereas, The operation of this grant project from 10/20/15 to 06/30/16 would cost \$45,000 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that acceptance of the grant from the National Association of County and City Health Officials (NACCHO) is authorized and the Health Department shall

accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to: 1. Commit funds within the Project/Grant Parent of the 2015 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Flu on Call Demonstration Grant:

- 4. Enter into subcontracts as detailed in the grant budget; and, be it
