THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,665,000 for a total estimated cost of these projects being \$11,249,000. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,665,000 with the total cost estimated to be \$11,249,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Elm St. - N. Teutonia Ave. to 1,600 feet west of N. Teutonia Ave. (WT410160010): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$45,000. This project is anticipated to be completed during the 2016 construction season.

4th Aldermanic District

N. Broadway - E. Wells St. to E. Kilbourn Ave. (SM495160009): Combined sewer lining.

(Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$83,000. This project is anticipated to be completed during the 2016 construction season.

E. Mason St. - N. Milwaukee St. to N. Jefferson St. (SM495160011): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$35,000. This project is anticipated to be completed during the 2016 construction season.

N. Milwaukee St. - E. Mason St. to E. Wells St. (SM495160012): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$56,000. This project is anticipated to be completed during the 2016 construction season.

W. Highland Ave. - N. 12th St. to N. 27th St. (WT410160008): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$9,000). The total estimated cost for this project including the requested amount is \$15,000. This project is anticipated to be completed during the 2016 construction season.

N. Van Buren St. - E. Michigan St. to E. Wisconsin Ave. (WT410160719): Abandon water main. (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$40,000. This project is anticipated to be completed during the 2016 construction season.

4th and 15th Aldermanic Districts

N. 27th St. - W. Highland Blvd. to W. Lisbon Ave. (WT410160011): Hydrant alterations. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2016 construction season.

6th Aldermanic District

W. Vine St. - N. Dr. Martin Luther King Jr. Dr. to N. 7th St. (SM495160008): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$342,000. This project is anticipated to be completed during the 2016 construction season.

This project is anticipated to be completed during the 2016 construction season.
