Whereas, Additional funding of \$150,000 will be provided by the Greater Milwaukee Foundation; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Community Development Grants Administration is authorized to accept the additional funding without further approval unless it terms change as indicated in Section 304-81, Milwaukee Code or Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to increase the current grant budget by \$150,000 for a total of up to \$300,000; and, be it
