Whereas, Lincoln Opportunity Fund has requested authorization from the Community Development Grants Administration (CDGA) to transfer their CDBG Revolving Loan Fund to the Wisconsin Women's Business Initiative Corporation; and

Whereas, The CDBG Revolving Loan fund has an approximate value of \$480,000 which consists of 8 outstanding loans and repayments from previous loans; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the transfer of the Revolving Loan Fund to the Wisconsin Women's Business Initiative Corporation is approved; and, be it

Further Resolved, That the Community Development Grants Administration is authorized to enter into a subrecipient contract with Wiscsonsin Women's Business Initiative Corporation for this approved activity; and, be it

Further Resolved, That the subrecipient organization shall submit budget and activity reports in amounts and according to any conditions approved by the Common Council and in accordance with File Number 74-92-5v, to the Community Development Grants Administration and the City Comptroller for review and approval; and, be it
