This resolution designates the Louis Auer & Son Houses at 2005 and 2009 East Kenwood Boulevard. Whereas, The Milwaukee Historic Preservation Ordinance, Section 308-81 of the Milwaukee

Code of Ordinances, as amended, provides that Historic Sites, Structures and Districts may be designated by the Common Council of the City of Milwaukee upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission recommends that the Louis Auer & Son Houses at 2005 and 2009 East Kenwood Boulevard be designated as Historic Sites; and

Whereas, These sites possess integrity of location, design, setting, materials, workmanship and association and fulfill the following criterion set forth in Section 308-81(2)(e):

e-5. Its embodiment of the distinguishing characteristics of an architectural type or specimen.

e-8. Its relationship to other distinctive areas, which are eligible for preservation according to a plan based on an historic, cultural or architectural motif.
