THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$690,000 for a total estimated cost of these projects being \$19,153,000. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction

After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$690,000 with the total cost estimated to be \$19,153,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd Aldermanic District

N. 76th St. - 110 feet north of W. Leon Terr. To 140 feet north of W. Sheridan Ave. (SM495160031): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$184,000. This project is anticipated to be completed during the 2016 construction season.

4th Aldermanic District

E. Chicago St. - N. Water St. to N. Milwaukee St. (SM495160030): Combined sewer lining.

(Nonassessable Sewer Maintenance Relay Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2016 construction season.

W. Highland Ave. - Old World Third St. to N. 4th St. (WT410170623): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2017 construction season.

W. Highland Ave. - N. 5th St. to N. 6th St. (WT410170624): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2017 construction season.

N. 6th St. - W. Highland Ave. to W. Juneau Ave. (WT410170625): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2017 construction season.

Alley between N. Broadway, E. Michigan St., N. Milwaukee St., and E. Wisconsin Ave. (SM495160032): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$37,000. This project is anticipated to be completed during the 2016 construction season.

4th and 6th Aldermanic Districts

W. Juneau Ave. - Old World Third St. to 200 feet west of S. 6th St. (WT410170622): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$8,000; Nonassessable Water Fund Budget Line 6410 -- \$17,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2017 construction season.

6th Aldermanic District

N. 5th St. - W. Juneau Ave. to W. McKinley Ave. (SM495160037): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$172,000. This project is anticipated to be completed during the 2016 construction season.

8th Aldermanic District

W. Greenfield Ave. - S. 33rd St. to S. 34th St. (SM495160029): Combined sewer lining and repair. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$43,000. This project is anticipated to be completed during the 2016 construction season.

W. Lapham St. - 160 feet east of S. 33rd St. to S. 34th St. (SM495160026): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$179.000. This project is anticipated to be completed during the 2016 construction season.

S. 33rd St. - W. Branting Ln. to W. Lapham St. (SM495160024): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$89,000. This project is anticipated to be completed during the 2016 construction season.

11th Aldermanic District

S. 60th St. - W. Morgan Ave. to W. Forest Home Ave. (SM495160023): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$368,000. This project is anticipated to be completed during the 2016 construction season.

12th Aldermanic District

S. 2nd St. at W. Washington St. (ST211160143): Laying of concrete curb and gutter. Laying of concrete walk. Removing and replacing pavement as necessary. Doing all necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$35,000. This project is anticipated to be completed during the 2016 construction season.

13th Aldermanic District

- W. Barnard Ave. S. 13th St. to S. 14th St. (SM495160025): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2016 construction season.
- E. Layton Ave. S. Howell Ave. to a point 300 feet east of S. Howell Ave. (SM495160035): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$123,000. This project is anticipated to be completed during the 2026 construction season.

14th Aldermanic District

S. Vermont Ave. - E. Oklahoma Ave. to E. Rhode Island Ave. (SM495160027): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$167,000. This project is anticipated to be completed during the 2016 construction season.

15th Aldermanic District

- N. 26th St. (East Side) W. Walnut St. to W. Meinecke Ave. (SM495160034): Combined sewer slip lining. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$8,090,000. This project is anticipated to be completed during the 2016 construction season.
- N. 26th St. (West Side) W. Walnut St. to W. Meinecke Ave. (SM495160033): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000). The total estimated cost for this

project including the requested amount is \$5,566,000. This project is anticipated to be completed during the 2016 construction season.

City Wide

Large diameter sewer cleaning and video taping (SM495160036): (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2016 construction season.

Paving coordination (SM495160028): (Nonassessable Sewer Maintenance Relay Fund -- \$300,000). The total estimated cost for this project is \$300,000. This project is anticipated to be completed during the 2016 construction season.

2016 Sewer work prior to paving (SM495160500): Sewer work prior to paving. (Nonassessable Sewer Maintenance Relay Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$1,500,000. This project is anticipated to be completed during the 2016 construction season.
