Resolution authorizing the issuance of a street occupancy permit to Balistrieri Environmental & Development Inc. for work at 1009 West Juneau Avenue.

This resolution authorizes City officials to issue a street occupancy permit to Balistrieri Environmental & Development Inc, allowing them to occupy half the roadway of West Juneau Avenue between North 10th Street and North 11th Street, as well as the sidewalk and the curb lane along North 10th Street between West Juneau Avenue and a point 130 feet to the south.

Whereas, Balistrieri Environmental & Development Inc has requested permission to occupy the south half of West Juneau Avenue between North 10th Street and North 11th Street for work at 1009 West Juneau Avenue; and

Whereas, Balistrieri Environmental & Development Inc has indicated that they need this area to rehabilitate 1009 West Juneau Avenue for approximately 3 months; and

Whereas, The Commissioner of Public Works may approve temporary occupancy of up to one-third of the width of the roadway while temporary use beyond that point must be approved by the Common Council; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the appropriate City officials are hereby authorized to issue a permit to Balistrieri Environmental & Development Inc, allowing occupancy of half of the
