THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$232,000 for a total estimated cost of these projects being \$1,950,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$232,000 with the total cost estimated to be \$1,950,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

3rd Aldermanic District

Alley between N. Bartlett Ave., E. Linnwood Ave., E. Locust St., and N. Newhall St. (ST212180101): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$20,000). The total estimated cost for this project including the

requested amount is \$75,000. This project is anticipated to be completed during the 2018 construction season.

11th Aldermanic District

W. Forest Home Ave. - S. 42nd St. to S. 45th St. (Including S. 43rd St. - A point south of W. Euclid Ave. to W. Oklahoma Ave.) (ST211140144): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000, Additional Funds). The total estimated cost for this project including the requested amount is \$820,000. This project was completed in 2015.

Alley between W. Warnimont Ave., W. Wilbur Ave., S. 83rd St., and S. 84th St. (ST212180103): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2018 construction season.

12th Aldermanic District

W. Lincoln Ave. at S. 9th Pl. (Intersection) (ST211160146): Traffic calming, curb. (Nonassessable Reconstruction Paving Fund -- \$7,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2016 construction season.

Alley between W. Burnham St., W. Rogers St., S. 11th St., and S. 12th St. (ST212180104): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2018 construction season.

13th Aldermanic District

Alley between S. Honey Creek Dr., S. Madeline Ave., W. Parnell Ave., and W. Ramsey Ave. (ST212180102): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2018 construction season.

Various Aldermanic Districts

2015 Sidewalk Scattered Sites (ST230150150): Laying concrete walk. Doing all necessary grading pertaining to said work. (Nonassessable Sidewalk Reconstruction Paving Fund -- \$125,000, Additional Funds). The total estimated cost for this project including the requested amount is \$605,000. This project was completed in 2015.

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
