THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,442,000 for a total estimated cost of these projects being \$20,256,810. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,442,000 with the total cost estimated to be \$20,256,810.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Glendale Ave. - N. Parkway Ave. to N. Green Bay Ave. (WT410170637): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2017 construction season.

2nd Aldermanic District

W. Carmen Ave. - N. 87th St. to N. 91st St. (WT410170650): Relaying water main. (Nonassessable

Water Fund Budget Line 5010 -- \$8,000; Nonassessable Water Fund Budget Line 6410 -- \$17,000). The total estimated cost for this project including the requested amount is \$360,000. This project is anticipated to be completed during the 2017 construction season.
