Subtitute resolution relative to the acceptance and funding of the 2016-17 SURVNET- Affordable Care Act (ACA) Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to accept and fund the SURVNET- Affordable Care Act (ACA) Project from the Wisconsin Department of Health Services in the amount of \$81,377 entirely grantor share. The purpose of the project is to maintain a countywide system for reporting communicable diseases in Milwaukee.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to maintain a county-wide system for reporting communicable diseases; and

Whereas, The operation of this grant project from 08/01/16 to 07/31/17 would cost \$81,377 entirely provided

by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that acceptance of this grant from the Wisconsin - Department of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2016 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled SURVNET-ACA Grant:Project/Grant GR0001600000 Fund 0150 Org 9990 Program 0001 Budget Year 0000 R999 Subclass Account 000600 Grantor Share Project Amount \$81.377

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget to these Project/Grant values the amounts required under the grant agreement; and be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;

- 2. Expend from the 2016 grant budget funds for training and out-of-town travel by departmental staff;
- 3. Expend from the 2016 grant budget funds for specific items of equipment.
- 4. Enter into subcontracts and leases as detailed in the grant budget.
