Resolved, By the Common Council of the City of Milwaukee, that the proper City officials are directed to execute the First Amendment to the Development Agreement, a copy of which is attached to this Common Council File; and, be it

Further Resolved, That the City shall make available to RACM up to \$435,000 in funds from TID No. 48, as authorized in Common Council File No. 160418, to allow RACM to supply the reimbursement to the Developer for the specified share of the cost of constructing the riverwalk improvements; and, be it

Further Resolved, That the City Attorney's office, in cooperation with the Commissioner of City Development, is authorized to make such further minor modifications to said First Amendment that are consistent with the intent and purpose of this resolution and which are mutually acceptable to the City Attorney, the Commissioner of City Development and the Developer.
