Substitute resolution terminating the sister city relationship with Carora, Venezuela.

This resolution terminates the City of Milwaukee's existing sister city relationship with Carora, Venezuela, as this relationship no longer meets the guidelines established by Sister Cities International.

Whereas, The Common Council created the Sister Cities Committee to assist in the establishment and maintenance of sister city relationships pursuant to Sister Cities International guidelines; and

Whereas, The Sister Cities Committee reviews requests for new relationships, investigates and makes recommendations to the Common Council concerning the establishment of new relationships and maintenance or termination of existing sister city relationships; and

Whereas, The Sister Cities Committee has reviewed the current sister city relationship with Carora, Venezuela, and recommends that the sister city relationship be terminated at the request of the local sponsor organization, Peace Action Wisconsin; and

Whereas, The sister city relationship between the City of Milwaukee and Carora, Venezuela is no longer active and does not have community support that fosters opportunities for reciprocal cultural, educational, municipal, business, professional or humanitarian exchanges and projects; now, therefore, be it
