THE CHAIR

A substitute ordinance relating to the change in zoning from Local Business, LB2, to Multi-Family Residential, RM1, to consolidate zoning to allow for expansion of an employee parking lot for the St. Ann Rest Home at 2008 South Muskego Avenue, located on the east side of South Muskego Avenue, south of West Vilter Lane, in the 8th Aldermanic District. This zoning change was requested by the Dominican Sisters Corporation and will consolidate the zoning of 2008 South Muskego Avenue with that of the St. Ann Rest Home, 2020 South Muskego Avenue, for expansion of an existing employee parking lot. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:
