Marquette University Pedestrian Crossings (ST211140185) File Number 140974: Removing and replacing curb and gutter and crosswalk as necessary. (Nonassessable Reconstruction Paving Fund -- \$4,000, Additional Funds). The total estimated cost for this project including the requested amount is \$27,000. This project is anticipated to be completed during the 2017 construction season.
