Whereas, the Social Development Commission, Sixteenth Street Community Health Centers, Inc., other partner agencies, and the City of Milwaukee recognize the need to promote the prevention of exposure to environmental lead hazards in the city of Milwaukee and educate the community about filtration as a way to reduce lead levels in water; and

Whereas, the City of Milwaukee recognizes the city's most vulnerable population, children under the age of 6, should have access to lead-free drinking water, now, therefore, be it
