THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,749,000 for a total estimated cost of these projects being \$12,676,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,749,000 with the total cost estimated to be \$12,676,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st, 4th, 7th and 12th Aldermanic Districts

Bioretention Maintenance Contract - North various locations (SM499160124): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2017 construction season.

2nd, 7th, and 10th Aldermanic District

North 60th Street Bioswales: N. 60th St. - W. Burleigh St. to W. Capitol Dr. (SM499160119): (Storm

Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$10,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2017 construction season.

#### 2nd and 9th Aldermanic District

West Mill Road Bioswales: W. Mill Rd. - N. 43rd St. to N. 91st St. (SM499160121): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$10,000). The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2017 construction season.

W. Pierce St. - S. 37th St. to S. 39th St. (SM495160091): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). West Good Hope Road Bioswales: W. Good Hope Rd. - N. 43rd St. to N. 91st St. (SM499160122): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$10,000). The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2017 construction season.
