Resolution relative to the acceptance and funding of the Analysis of Impediments awards from various local Municipalities.

This resolution authorizes the City of Milwaukee - Community Development Grants Administration to accept the Analysis of Impediments awards up to \$150,000 from various local municipalities. Each municipality will have a share of the total project.

Whereas, The Department of Housing and Urban Development requires entitlement communities receiving Community Development Block Grant funding to periodically prepare an Analysis of Impediments to Fair Housing Choice (AI); and

Whereas, The City of West Allis has provided \$10,000 and the City of Wauwatosa has provided \$24,900 to the City of Milwaukee - Community Development Grants Administration as their portion of the countywide AI report; and

Whereas, The operation of this award from January 1, 2017 through December 31, 2017 would cost up to \$150,000 will be provided by several local municipalities; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, the Community Development Grants Administration shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it
