Substitute resolution relating to a Minor Modification to the Detailed Planned Development known as Block 1 - Arena Master Plan for site, building and signage changes to the previously approved arena on land located on the south side of West Juneau Avenue, west of North 4th Street, in the 4th Aldermanic District.

This zoning change was requested by Head of the Herd, LLC to permit modifications to the previously approved site plan, building elevations and signage for the future Milwaukee Bucks Arena.

Whereas, Section 295-907-2(i) of the Milwaukee Code of Ordinances permits minor modifications to planned developments after approval of the Common Council; and

Whereas, The detailed plan for a planned development ("DPD") known as Block 1 - Arena Master Plan, located on the west side of North 4th Street, south of West Juneau Avenue, was approved by the Common Council of the City of Milwaukee on May 24, 2016 under File No. 151653; and

Whereas, The minor modification to Block 1 - Arena Master Plan to revise the plaza design on the east side of the arena, provide details for a LED sign at the Juneau and 6th Street entrance and add an interactive monument sign at the corner of Highland and 4th Street is consistent with the spirit and intent of the approved plan and will not adversely affect the surrounding development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set forth herein; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the minor modification:

- 1. Is consistent with the spirit and intent of the previously approved DPD.
- 2. Will not change the general character of the DPD.
- 3. Will not cause a substantial relocation of principal or accessory structures.
- 4. Will not cause a substantial relocation or reduction of parking, loading or recreation areas.
- 5. Will not cause a substantial relocation of traffic facilities.
- 6. Will not increase the land coverage of buildings and parking areas.
- 7. Will not increase the gross floor area of buildings or the number of dwelling units.
- 8. Will not reduce the amount of approved open space, landscaping or screening; and, be it

Further Resolved, That the minor modification is approved in accordance with the Milwaukee Code of Ordinances, Section 295-907-2(i). DCD: Vanessa. Koster: kdc 02/15/17
