### THE CHAIR

Substitute motion relating to the locations of various Milwaukee County Transit System bus stops. This motion eliminates existing bus stops at various locations throughout the city. It also authorizes the establishment of new bus stops at various locations throughout the city.

It is moved, By the Common Council of the City of Milwaukee, that the following bus stops are eliminated:

1. East Meinecke Avenue, eastbound, at North Fratney Street (southwest corner of intersection).
2. East Meinecke Avenue, eastbound, at North Weil Street (southwest corner of intersection).
3. West Capitol Drive, eastbound, at West Grantosa Drive (southwest corner of intersection). *Note: Stop is being relocated to a point on West Capitol Drive 80 feet east of the painted crosswalk over West Capitol Drive on the east side of the intersection.*
4. West Capitol Drive, eastbound, at North 100<sup>th</sup> Street (southwest corner of intersection). *Note: Stop is being relocated to a point approximately 90 feet east of the painted crosswalk over West Capitol Drive on the east side of its intersection with North 100<sup>th</sup> Street.*
5. West Hopkins Street, southeastbound, at North 22<sup>nd</sup> Street (south side of intersection). *Note: Stop is being moved 43 feet northwest on West Hopkins Street.*

; and

It is further moved, That the establishment of new bus stops at the following locations is authorized:

1. East Meinecke Avenue, eastbound, at North Bremen Street (southwest corner of intersection).
2. West Capitol Drive, eastbound, at a point 80 feet east of the painted crosswalk over West Capitol Drive on the east side of its intersection with West Grantosa Drive. *Note: Stop is being relocated from a location on the southwest corner of the intersection of West Capitol Drive and West Grantosa Drive.*
3. West Capitol Drive, eastbound, at a point approximately 90 feet east of the painted crosswalk over West Capitol Drive on the east side of its intersection with North 100<sup>th</sup> Street. *Note: Stop is being relocated from a location on the southwest corner of the intersection of West Capitol Drive and North 100<sup>th</sup> Street.*
4. West Hopkins Street, southeastbound, at a point 43 feet northwest of the existing bus stop on the south side of the intersection of Hopkins Street and North 22<sup>nd</sup> Street. *Note: Existing bus stop is being eliminated.*
