Resolution approving a final Certified Survey Map for land located on the south side of West Silver Spring Drive and east of North 68th Street to divide a portion of one parcel into multiple parcels and to dedicate land for public alley purposes, in the 2nd Aldermanic District.

This resolution approves a final Certified Survey Map that divides a portion of one parcel into multiple parcels to accommodate a proposed development known as Victory Manor and to dedicate land for public alley purposes to provide access to the rear of the new parcels.

Whereas, The Milwaukee Code of Ordinances, Chapter 119-5, Subdivision Regulations,

requires City Plan Commission ("CPC") approval, conditional approval or disapproval of all Certified Survey Maps ("CSMs"), which provide dedication of land to the City of Milwaukee ("City") for public purposes; and

Whereas, The City received one final CSM, a copy of which is attached to this Common Council File, which dedicates land to the City for public purposes; and

Whereas, In compliance with the above-referenced chapter of the Milwaukee Code of Ordinances, CPC has reviewed and recommended approval of said CSM; now, therefore, be it
