This resolution approves a final Certified Survey Map that divides a portion of one parcel into multiple parcels to accommodate a proposed development known as Victory Manor and to dedicate land for public alley purposes to provide access to the rear of the new parcels. Whereas, The Milwaukee Code of Ordinances, Chapter 119-5, Subdivision Regulations,

requires City Plan Commission ("CPC") approval, conditional approval or disapproval of all Certified Survey Maps ("CSMs"), which provide dedication of land to the City of Milwaukee ("City") for public purposes; and
