Substitute resolution authorizing the acceptance and expenditure of contributions received by the Milwaukee Police Department from federally forfeited tangible property or cash for increased or enhanced law enforcement efforts.

This resolution authorizes \$1,183,045 to fund items in accordance with the guidelines of the Asset Forfeiture Sharing Program.

Whereas, The Federal government has established specific guidelines for expending funds received

as a result of the Asset Forfeiture Fund Program; and

Whereas, The Police Department currently has funds held in trust (Account No. 0678-2110-9XXX-D33X 662201) to increase or enhance law enforcement efforts in the City of Milwaukee; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the City Comptroller is authorized to transfer up to \$1,183,045 from the Police Department's Federal Forfeiture Trust Fund (Account Number 0678-2110-9XXX-D33X-662201), to the contribution/revenue account entitled Federal Forfeiture Contribution Revenue (Account Number 0001-3311-985012); and, be it

Further Resolved, That upon transfer of these funds, the City Comptroller is authorized and directed to transfer \$1,183,045 from the Federal Forfeiture Revenue Contribution Account to the Police Department's budget as follows:
