City of Milwaukee*, United States District Court for the Eastern District of Wisconsin, Case No. 2:15-cv-175-LA, *Boardroom Entertainment MKE, LLC v. City of Milwaukee*, Milwaukee Circuit Court, Case No. 15-CV-8812, *Boardroom Entertainment MKE, LLC v. City of Milwaukee*, United States District Court for the Eastern District of Wisconsin, Case No. 2:15-cv-53, and *Mookie Exotic, LLC v.
