THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,211,000 for a total estimated cost of these projects being 15,847,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,211,000 with the total cost estimated to be \$15,847,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Bobolink Ave. - N. 27th St. to N. Teutonia Ave. (WT410180680): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$22,000). The total estimated cost for this project including the requested amount is \$345,000. This project is anticipated to be completed during the 2018 construction season.

W. Fairmount Ave. - N. 47th St. to 30 feet west of N. 48th St. (WT410180646): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$75,000.

This project is anticipated to be completed during the 2018 construction season.

W. Luscher Ave. - N. 48th St. to N. 49th St. (WT410180649): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2018 construction season.

N. 47th St. - W. Hampton Ave. to W. Villard Ave. (WT410180647): Relaying water main and abandon water main. The total estimated cost for this project including the requested amount is \$485,000. This project is anticipated to be completed during the 2018 construction season.

The total estimated cost for this project including the requested amount is \$435,000. This project is anticipated to be completed during the 2018 construction season.
