Whereas, The City of Milwaukee will be the lead agency of the project design and construction; and

Whereas, This projects are programmed for construction in 2017; and

Whereas, Funding for the construction phase of the project is included in resolution 170020 (ST214170104); now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public works is hereby authorized to execute the project agreement titled "Cost Sharing Memo of Understanding Between the City of Milwaukee and the City of Wauwatosa" for the cost sharing of the rehabilitation of North 60th Street between West Vliet Street to West Center Street, and North 100th Street from West Keefe Avenue to West Lisbon Avenue in the 5 th and10th Aldermanic Districts copies of which are attached to Common Council Resolution File Number 170022, and are incorporated by reference as though set forth in full.
