Whereas, North 8th Street between West Juneau Avenue and West Winnebago Street was vacated on February 11, 2014 by Common Council File Number 061395; and

Whereas, The City owns a12-inch diameter sanitary sewer and a 15-inch diameter storm sewer in said vacated North 8th Street; and

Whereas, The vacated lands are now owned by MKE Hotel LLC; and

Whereas, Said sewers no longer serve the interest of the City; and

Whereas, MKE Hotel LLC has agreed to accept ownership of said sewers; now, therefore, be it
