THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$1,751,000 for a total estimated cost of these projects being \$2,021,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$1,751,000. The total estimated cost of these projects is \$2,021,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

### 2nd Aldermanic District

N. 65th St. - W. Ruby Ave. to W. Armitage Ave. (WT410170640) File Number 151848: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$210,000). The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2017 construction season.

#### 4th Aldermanic District

E. Mason St. - N. Jefferson St. to N. Van Buren St. (SM495160081) File Number 170143: Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$45,000, Additional Funds). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed during the 2017 construction season.

Alley bounded by N. Broadway, W. Michigan St., N. Milwaukee St., and W. Wisconsin Ave. (SM495160032) File Number 151746: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$66,000). The total estimated cost for this project including the requested amount is \$76,000. This project is anticipated to be completed during the 2017 construction season.

#### 8th Aldermanic District

W. Branting Ln. - S. 33rd St. to 175 east of S. 33rd St. (SM495160088) File Number 161153: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$35,000). The total estimated cost for this project including the requested amount is \$45,000. This project is anticipated to be completed during the 2017 construction season.

W. Lapham St. - 160 feet east of S. 33rd St. to S. 34th St. (SM495160026) File Number 151746: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$232,000). The total estimated cost for this project including the requested amount is \$244,000. This project is anticipated to be completed during the 2017 construction season.

W. Orchard St. - S. 29th St. to S. 31st St. (SM495160075) File Number 160696: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$117,000). The total estimated cost for this project including the requested amount is \$129,000. This project is anticipated to be completed during the 2017 construction season.

S. 33rd St. - W. Branting Ln. to W. Lapham St. (SM495160024) File Number 151746: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$88,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2017 construction season.

#### 10th Aldermanic District

W. Juneau Ave. - 200 feet west of N. 46th St. to 315 feet west of N. 46th St. (SM495160080) File Number 170143: Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$7,000, Additional Funds). The total estimated cost for this project including the requested amount is \$38,000. This project is anticipated to be completed during the 2017 construction season.

#### 13th Aldermanic District

E. Layton Ave. - S. Howell Ave. to a point 300 feet east of S. Howell Ave. (SM495160035) File Number 151746: Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$90,000). The total estimated cost for this project including the requested amount is \$102,000. This project is anticipated to be completed during the 2017

construction season.

S. Taylor Ave. - S. Whitnall Ave. to E. Bolivar Ave. (SM495160015) File Number 151521: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$189,000). The total estimated cost for this project including the requested amount is \$201,000. This project is anticipated to be completed during the 2017 construction season.

#### 13th and 14th Aldermanic Districts

S. Whitnall Ave. - S. Quincy Ave. to S. Pine Ave. (SM495160018) File Number 151521: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$124,000). The total estimated cost for this project including the requested amount is \$136,000. This project is anticipated to be completed during the 2017 construction season.

#### 14th Aldermanic District

S. Kinnickinnic Ave. - E. Ohio Ave. to 100 feet north of E. Malvern Pl. (SM495150058) File Number 150997: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$38,000). The total estimated cost for this project including the requested amount is \$48,000. This project is anticipated to be completed during the 2017 construction season.

#### Various Aldermanic Districts

Bridge traffic movement improvements (BR100170108): Bridge traffic configuration improvements to various projects. (City Share Non-assessable Structure Fund -- \$180,000). The total estimated cost for this project including is \$180,000. This project is anticipated to be completed during the 2017-2018 construction seasons.

N./S. 6th St. cable stay bridge and W. Vliet St. bridge over CPRW (BR100170109) File Number 170278: Epoxy overlay to the North and South 6th Street cable stay bridge sidewalks and West Vliet Street Bridge over CPRW. (City Share Non-assessable Structure Fund -- \$330,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2017 construction season.
