Substitute resolution to ratify and confirm the final agreement between the City of Milwaukee and Milwaukee Police Supervisors' Organization.

The purpose of this substitute resolution is to confer common council approval, ratification and confirmation on memorandum of understanding between the City of Milwaukee negotiating team and Milwaukee Police Supervisors' Organization covering wages, hours and conditions of employment for the time periods commencing January 1, 2007, through December 31, 2009.

Whereas, The total agreement between the city negotiating team and Milwaukee Police Supervisors' Organization, for the time period commencing January 1, 2007, through December 31, 2009 has been reduced to writing; and

Whereas, The memorandum of understanding embodying the agreement reached by the parties and

the arbitrator's award, copies of which are attached to Common Council File No. 081273 and incorporated herein as though fully set forth at length, wasS executed subject to ratification by the Common Council; now, therefore, be it

Resolved, By the common council of the City of Milwaukee, that the agreement between the city negotiating team and Milwaukee Police Supervisors' Organization be approved; and be it

Further Resolved, That the city negotiating team is hereby authorized and directed to reduce the agreement to a formal contract between the union and the city; and be it

Further Resolved, That the proper city officials are hereby authorized and directed to execute formal contract between the City of Milwaukee and Milwaukee Police Supervisors' Orgaization which reflect the terms of the agreement; and be it

Further Resolved, That the proper city officials are hereby authorized and directed to take the necessary action or to make the necessary recommendations to the common council or the appropriate committees or boards to implement the terms of this agreement; and be it

Further Resolved, That such sums as are necessary for the implementation of the aforementioned labor contract in accordance with the terms and conditions be obtained for and charged to the appropriate departmental budget accounts in accordance with the customary reporting and accounting requirements.
