This motion suspends for 60 days the Class "B" Tavern license of Jennie M. Nuell, Agent for Maximum Capacity, LLC, for the premises at 4001 W. Fond du Lac Avenue ("All Star Sports Bar") in the 7th aldermanic district.

Whereas, The Licenses Committee received a notarized complaint from the Chief of Police of the Milwaukee Police Department requesting the revocation of the Class "B" Tavern license for the premises at 4001 W. Fond du Lac Avenue ("All Star Sports Bar") in the 7th aldermanic district; and

Whereas, The Licenses Committee held evidentiary hearings on March 6, May 11 and May 29, 2009; and

Whereas, After considering the complaint, witness and police testimony, and the police report, the Committee found that enough evidence existed to justify a 60-day suspension of the Class "B" Tavern license; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Class "B" Tavern license for the premises at 4001 W. Fond du Lac Avenue ("All Star Sports Bar") be suspended for 60 days.
