Further Resolved, That up to \$742,330.82 from the Common Council Contingent Fund (#0001-9990-C001-006300) (2008) be transferred to the Department of Public Works Infrastructure Division Account (#0001-5230-R999-006300) (2008) if necessary; and, be it

Further Resolved, That up to \$437,384.15 from the Common Council Contingent Fund (#0001-9990-C001-006300) (2008) be transferred to the Department of Public Works Operations Division Account (#0001-5230-R999-006300) (2008) if necessary.
