Substitute resolution relative to the acceptance and funding of the 2017-18 SURVNET- Affordable Care Act (ACA) Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to accept and fund the SURVNET- Affordable Care Act (ACA) Project from the Wisconsin Department of Health Services in the amount of \$19,665 entirely grantor share. The purpose of the project is to maintain a countywide system for reporting communicable diseases in Milwaukee.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to maintain a county-wide system for reporting communicable diseases; and

Whereas, The operation of this grant project from 08/01/17 to 07/31/18 would cost \$19,665 entirely provided by the grantor; now, therefore, be it

1. Commit funds within the Project/Grant Parent of the 2017 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled SURVNET-ACA Grant:Project/Grant GR0001700000

Fund 0150 9990 Org 0001 Program Budget Year 0000 Subclass R999 Account 000600 Grantor Share Project Amount \$19,665

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget to these Project/Grant values the amounts required under the grant agreement; and be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

- 1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Expend from the 2017 grant budget funds for training and out-of-town travel by departmental staff;
- 3. Expend from the 2017 grant budget funds for specific items of equipment.
- 4. Enter into subcontracts and leases as detailed in the grant budget.
