Is consistent with the spirit and intent of the previously approved DPD. 2. Will not change the general character of the DPD. 3. Will not cause a substantial relocation of principal or accessory structures. 4. Will not cause a substantial relocation or reduction of parking, loading or recreation areas. 5. Will not cause a substantial relocation of traffic facilities. 6. Will not increase the land coverage of buildings and parking areas. 7. Will not increase the gross floor area of buildings or the number of dwelling units. 8. Will not reduce the amount of approved open space, landscaping or screening; and, be it Further Resolved, That the minor modification is approved in accordance with the Milwaukee Code of Ordinances, Section 295-907-2(i).
