ALD. ZIELINSKI AND STAMPER

A substitute ordinance relating to establishment of a citywide worker safety telecommunication policy. 350-222 cr

This ordinance establishes a requirement for all city employees who work at sites other than municipal buildings to carry city-issued cellular telephones while engaged in city work. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 350-222 of the code is created to read:

## 350-222. Cellular Telephones.

- **1.** AUTHORITY. The department of employee relations shall create, issue, and implement a policy for all employees working at sites other than municipal buildings to carry city-issued cellular telephones while engaged in city work in accordance with the procedure specified in sub. 2.
- **2.** PROCEDURE. The department of employee relations shall promulgate rules for the implementation and issuance of cellular telephones.
